

RESOLUTION: 8 OF 2015

AMENDMENT TO PSCBC RESOLUTION 2 OF 2015 FOR SALARY ADJUSTMENTS AND IMPROVEMENTS ON CONDITIONS OF SERVICE IN THE PUBLIC SERVICE FOR THE PERIOD 2015/16 - 2017/18

1. OBJECTIVE

To allow for the amendment of clause 3 of PSCBC Resolution 2 of 2015, determining the multi-year salary adjustment of employees for the period 2015/16 to 2017/18.

2. SCOPE

- This agreement binds the Employer and employees who:
 - 2.1.1, are employed by the State; and
 - 2.1.2. fall within the registered Scope of the Council.

THE PARTIES TO COUNCIL AGREE TO REPLACE CLAUSE 3 OF PSCBC **RESOLUTION 2 OF 2015, WITH THE FOLLOWING CLAUSE:**

3. SALARY ADJUSTMENTS

- The salary adjustment for the period 1 April 2015 to 31 March 2016, effective from 3.1 1 April 2015, will be 7%.
- The salary adjustment, for the period 1 April 2016 to 31 March 2017, effective from 3.2 1 April 2016, will be based on the average projected CPI plus 1%.
- The salary adjustment for the period 1 April 2017 to 31 March 2018, effective from 3.3 1 April 2017, will be based on the average projected CPI plus 1%.
- The forecasts of National Treasury shall be used to determine the average projected 3.4 CPI.
